QUITCLAIM DEED

KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto Bruce Hurst hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, Sate of Oregon, described as follows, to-wit:

Lots 1 through 5 and Lots 20 through 24 of vacated Block 1, together with the vacated alley in Block 1 and 1/2 of vacated Sixth Street, First Avenue and all of Fifth Street located in First Addition To Sprague River. Also Lots 6 through 19, Block 1, First Addition To Sprague River, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

**Subject to** covenants, conditions, reservations, easements, restrictions, rights, rights of way and all matters appearing of record.
