Proof shall consist of a current Certificate of Taxes Paid (Department of Revenue Form 113), or a signed statement from the county that all property taxes and special assessments for the current tax year and all delinquent property taxes and special assessments have been paid.

5) A copy of the recorded exemption application (this form) must be received by DMV within 30 days of the date of recording with the
