PARCEL 1A: All that portion of Section 31, T. 39 S. R. 8 E.W.M. lying Northeasterly of the Klamath River and southeasterly and southwesterly of the easterly and southerly rights-of-way of Oregon State Highway No. 66 as the same is presently located and constructed.
