## EXHIBIT "A" LEGAL DESCRIPTION

## PARCEL 1:

That part of the N1/2 of the SE1/4 of Section 3, Township 36 South, Range 10 East of the Willamette Meridian, Klamath County, Oregon, lying East of the Sprague River Highway, Klamath County, Oregon.

## PARCEL 2:

The following described real property in Klamath County, Oregon:

A tract of land situated in Section 3, Township 36 South, Range 10 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:
