EXHIBIT "A" LEGAL DESCRIPTION

Parcel 1 of Land Partition 17-90, situated in Lot 1 of HOMEDALE, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, being in the NW1/4 NE1/4 of Section 11, Township 39 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, being more particularly described as follows:

Beginning at the initial point, as marked with a $5/8" \times 30"$ iron pin, with a Tru-Line Surveying plastic cap, on the Northeasterly right of way line of Walton Drive, from which the Southeasterly corner of said Lot 1 bears South 43° 35' 35" East 6.2 feet; thence North 43° 35' West along said Northeasterly right of way line 229.65 feet to the true point of beginning; thence North 39° 46' 34" East 95.69 feet; thence along the Northerly line of this Tract, South 66° 07' 50" East 102.32 feet; thence South 41° 11' 07" West 134.84 feet to the Northeasterly right of way line of Walton Drive; thence along said Northeasterly right of way line North 43° 35' West 95.72 feet to the point of beginning.
