DRAINAGE EASEMENT

RECITALS

JELD-WEN, inc., ("JELD-WEN") is the owner of a parcel of real property known as Lot 105, Tract 1277, Klamath County, Oregon ("Lot"), which is located in a subdivision commonly known as "Harbor Isles." JELD-WEN wishes to reserve an easement for drainage facilities as follows:

NOW, THEREFORE, JELD-WEN does hereby reserve, for itself and its successors and assigns (all together hereinafter "JELD-WEN"), a sixteen feet (16") wide drainage easement over the southernmost portion of Lot 105, Tract 1277, Klamath County, Oregon as shown on the attached "Exhibit A" that shall run with the land in perpetuity (the "Easement"). Within the Easement, no structure, planting or other material shall be placed or permitted to remain which may damage or interfere with the installation or maintenance of drainage facilities, or which may change the direction of flow of drainage channels in the Easement, or which may obstruct or retard the flow of water through drainage channels in the Easement. The Easement shall be maintained continuously by the owner of the Lot, except for the drainage pump, piping, electrical wires and related drainage facilities for which JELD-WEN is, and shall be, responsible. The owner of the Lot shall be responsible for paying the real property taxes applicable to the Easement.


