(a) on the date next written below; and for the period written above(b) on the date I am adjudged incompetent by a court of proper jurisdiction

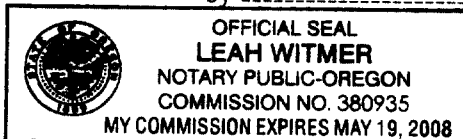
