- 5) **Note:** This form may not be used if the owner or co-owner of the manufactured structure holds a leasehold estate of 20 or more years in the land.

- 7) Furnish a copy to the county tax collector.

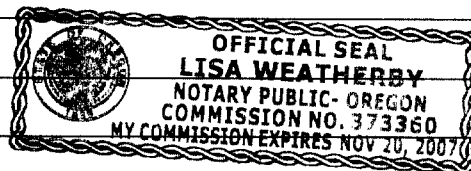
