The land referred to in this Guarantee is situated in the State of Oregon, County of Klamath and is described as follows:

Beginning at an iron axle which lies South 89°51' West a distance of 30 feet and South 1°14' East a distance of 42.05 feet from the quarter corner common to Sections 2 and 3, Township 39 South, Range 9 E. W. M., and which iron axle is in the Southerly right of way line of the Dalles-California Highway 40 feet South of the center line thereof, and 30 feet West of the Section line common to Sections 2 and 3, Township 39 South, Range 9 E. W. 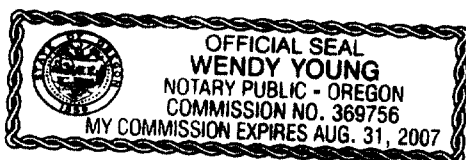


