A. DAVID W. DUNHAM and CHRISTINE A. DUNHAM, Grantor, executed and delivered to ASPEN TITLE AND ESCROW, INC., Trustee for the benefit of SECURITY BANK, Beneficiary, a Trust Deed dated October 19, 2000 and recorded on October 25, 2000, in the Official Records of Klamath County, Oregon as Volume M00, Page 38954 (the Trust Deed).
