The Real Property or its address is commonly known as 2300 Clairmont Drive, Klamath Falls, OR 97601.

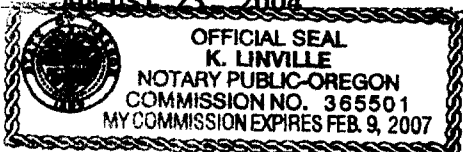
