Order 2005 - 006

WHEREAS, Edward P. O'Neill entered into an agreement with Klamath County on May 9, 2003, for the purchase of real property described as:

Lot 6, Block 63, Fifth Addition To Nimrod River Park, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, and the W½ NE¼ NE¼ SE¼ NE¼ of Section 1, Township 36 South, Range 11 East of the Willamette Meridian, Klamath County, Oregon.

Subject to covenants, conditions, reservations, easements, restrictions, rights, rights of way and all matters appearing of record.

WHEREAS, the real property was purchased for the sum of \$2,100.00 and a down payment of \$525.00 was made on May 9, 2003; and

WHEREAS, Edward P. O'Neill failed to make the May 9, 2004, annual installment and 2003 taxes as required by Sections 2, 3, 8 and 9 of the Land Sale Agreement. The installment and taxes are now in default under the terms of the Land Sale Agreement; and

WHEREAS, on May 26, 2004, a letter was mailed regular and certified to Edward P. O'Neill requesting the May 9, 2004, annual installment in the amount of \$703.22 and the 2003 taxes in the amount of \$35.98 be paid in full on the real property by June 25, 2004, or the county would declare the entire balance due and payable. A return receipt to Klamath County Property Sales Department was received on June 17, 2004; and

WHEREAS, a final notice was mailed regular and certified on June 29, 2004, requesting the remaining balance, interest and recording fee in the amount of \$1,780.26 and the 2003 taxes in the amount of \$35.98 be paid by July 9, 2004; and

WHEREAS, no payments have been made and the Land Sale Agreement is now in DEFAULT.

NOW, THEREFORE, IT IS HEREBY ORDERED, that the Land Sale Agreement between Klamath County and Edward P. O'Neill dated May 9, 2003, is hereby cancelled. A certified copy

The appeal shall be tried by the court as an action not triable by right to a jury. If appeal is not so taken or if it results upon trial in an affirmance of the order of cancellation, such order shall become absolute and the real property so forfeited again may be sold, without notice.
