Beginning at the Southeast corner of said Section 8, as marked by a 5/8" Iron pin; thence North 89°45'04" West, along the South line of said Section 8, 774.90 feet; thence North 00°14'56" East 30.00 feet to a point on the Northerly right of way line of Lower Klamath Road; thence North 32°28'38" East 27.40 feet to a point 1 foot Northwesterly of an existing fence line; thence along a line 1 foot Northwesterly of said fence line, North 41°09'50" East 28.19 feet, North 51°32'46" East 63.12 feet, North 53°04'23" East 191.71 feet, North 50°07'36" East 268.88 feet, North 45°27'10" East 167.78 feet, North 41°49'20" East 89.91 feet, along the arc of a curve to the left (Radius = 500.00 feet and Central angle = 29°02'58") 253.50 feet, North 12°46'22" East 36.94 feet, and North 08°40'58" East 70.25 feet, thence along an existing fence South 88°36'12" East 17 feet, more or less, to a point on the East line of said Section 8; thence Southerly, along said East line, 917.14 feet to the point of beginning.
