ASSIGNMENT OF CONTRACT and WARRANTY DEED

KNOW ALL BY THESE PRESENTS that the undersigned, hereinafter called the assignor, for the consideration hereinafter stated, has sold and assigned and hereby does grant, bargain, sell, assign and set over unto WITHOUT RECOURSE OR INDEMNIFICATION, MICHAEL DAWSON, hereinafter called the assignee, and to assignee's heirs, successors and assigns, all of the vendor's right, title and interest in and to that certain contract for the sale of real estate dated APRIL 24, 2002, between LANDGOAL LLC and MICHELLE T. KUNZ, as seller and as buyer, which contract is recorded in the Records of Klamath County, Oregon, in book/reel/volume No. M04 at page 11972, and/or as fee/file/instrument/microfilm/reception No. (indicate which), reference to that recorded contract hereby being expressly made, together with all of the right, title and interest of the assignor in and to all moneys due and to become due thereon. The assignor also hereby conveys to the assignee the property described in the contract and the legal title thereto which is held to secure performance of the vendee's obligation created thereby.
