EXHIBIT "A" LEGAL DESCRIPTION

PARCEL 1:

Lot 1 of Section 18 in Township 24 South, Range 8 East of the Willamette Meridian, Klamath County, Oregon and H.E. Survey No. 83 embracing a portion of said Township, more particularly described as follows:

Beginning at corner No. 1 identical with the Northwest corner of Section 18, Township 24 South, Range 8 East of the Willamette Meridian, Klamath County, Oregon; thence South 88° 36' East 60 chains to corner No. 2; thence North 10 chains to corner No. 3; thence North 45° West 14.15 chains to corner No. 4; thence North 88° 19' West 50 chains to corner No. 5; thence South 20° to corner No. 1 the place of beginning.

Also a portion of Township 24 South, Range 7 East of the Willamette Meridian, Klamath County, Oregon more particularly described as follows:
