**LIMITED POWER OF ATTORNEY**

Know all men by these present that effective November 16, 2004, the Secretary of Housing and Urban Development of Washington, D.C. (HUD), does hereby make, constitute, and appoint **Michael C. Meyer, Michael Sherman, Lisa Talbaldo, Michelle Rodriguez-Jamias, Monica Miles, Rhona Miles, Toni Johnson, Mary Ann Gontarz, Lew Carlson, Thomas Andrade, Song Vue, Sarah Oyler, Tanya Stone, Main Moa, Cha Herr, Sarah Saetern, Tricia Herrera and Frances Heffentrager** of Golden Feather Realty Services, 1600 Sacramento Inn Way, Sacramento, CA, 95815, each of whom may act individually as a true and lawful attorney-in-fact to act in the name, place and stead of the Secretary of HUD for the purposes set forth below:

Any third party may rely upon this document as evidence of Contractor's authority to continue to exercise the powers granted herein until the Termination Date, unless a Revocation has been recorded in the public records of the county where the property is located, or unless such third party has actual notice of the Revocation.

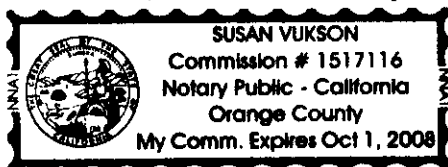


