in the place of the trustee named above;





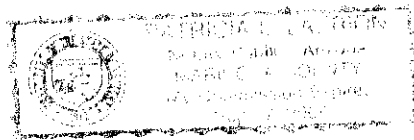
