




EXHIBIT "A" LEGAL DESCRIPTION

A piece or parcel of land situate in the SW1/4 of the SW1/4 of Section 26, Township 38 South, Range 11 1/2 East of the Willamette Heridian, Klamath County, Oregon, and being more particularly described as
