
David H. Kalus, Grantor, conveys to **David H. Kalus and Linda K. Kalus, as tenants by the entirety**, Grantee, the following described real property:

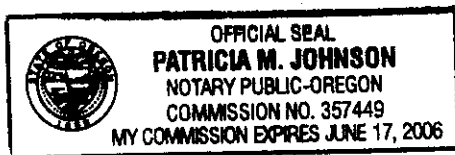

LEGAL DESCRIPTION:
