fully do or cause to be done by virtue of these presents.

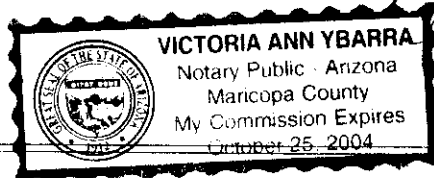
