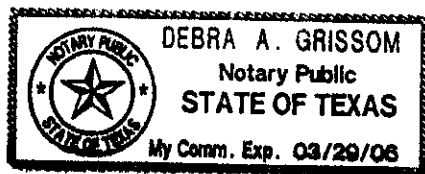

A portion of the NW 1/4 SW 1/4 of Section 7, Township 39 South, Range 10 East of the Willamette Meridian, Klamath County Oregon, being more particularly described as follows:

Beginning at the point where the North line of that certain parcel of land conveyed to R. R. Proebstel by Deed recorded in Volume 120 page 575, Klamath County Deed Records, intersects the West line of Section 7, Township 39 South, Range 10 East of the Willamette Meridian, Klamath County, Oregon, which point of beginning bears South along said Section line, 1115.6 feet from the one quarter corner on the West side of said Section 7; thence South 89°51' East along the North line of said R.
