2. GN Mortgage, LLC referred to herein as "lender" is the owner and holder of the deed of trust dated L2804, executed by Steven V. Belden & B S Belden IV under auditor's file No. m05-01880, records of Klamath County (which is to be recorded concurrently herewith).

3. **Steven V. Belden**, referred to herein as "owner", is the owner of all the real property described in the deed of trust identified above in Paragraph 2.

4.
