hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto Michael E. Long, Inc.

property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath

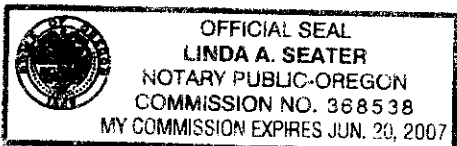
