The consideration for this transfer is \$ 44,063.97.



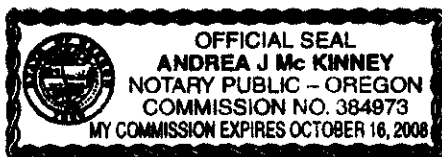
