AGREEMENT FOR TERMINATION OF EASEMENT

THIS AGREEMENT made and entered into by and between SCOTT F. JOHNSTON and CHERYL A. JOHNSTON, Husband and Wife, hereinafter referred to as "Johnstons" and ROBERT E. SHAW and LANA J. SHAW, Husband and Wife, hereinafter referred to as "Shaws";

W I T N E S S E T H

By a certain GRANT OF EASEMENT dated the 16th day of July, 2003 and recorded at Vol. M03, Page 49647, Shaws granted to Grantees CLARENCE WESLEY HEADRICK II and SANDRA JEAN HEADRICK a ten foot easement to connect an existing water line and to make repairs thereto; and

WHEREAS, Johnstons are successors in interest and current fee owners of the real property previously owned by Clarence Wesley Headrick II and Sandra Jean Headrick, and the interest in the dominant estate benefited by the Grant of Easement recorded in Vol. M03, Page 49647; and

WHEREAS, Johnstons have now ceased to use the existing water lines and well located on Shaws' property; now, therefore,

IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES that the certain GRANT OF EASEMENT dated the 16th day of July, 2003, and recorded at Vol. M03, Page 49647 is by this agreement relinquished and terminated such that neither the dominant property now owned by Johnstons nor the serviant property still owned by Shaws be burdened or benefited by the aforementioned GRANT OF EASEMENT recorded at Vol. M03, Page 49647.

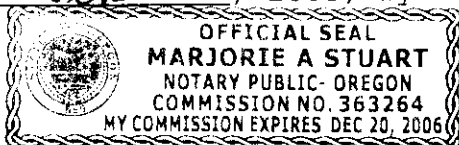

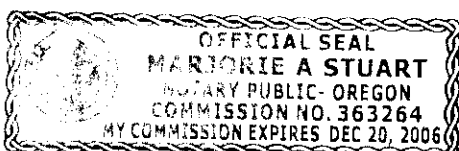
