DEED OF FULL RECONVEYANCE

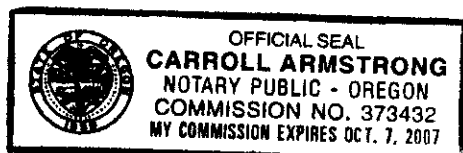
