INSTRUCTIONS:

- 2) Complete all areas of the form and sign before notary;
- Provide duplicate original certification to the county recorder where located;
- Surrender the Manufacturer's Certificate of Origin (MCO) or Out-of-State Title to DMV;
- Mail to: DMV Title Exemption Desk, 1905 Lana Ave NE, Salem. Oregon 97314; and
- 6) Furnish a copy to the county tax collector.
