

EXHIBIT "A"
LEGAL DESCRIPTION

The Southeasterly 13.33 feet of Lot 5, and the Northwesterly 23.33 feet of Lot 6, Block 94, BUENA VISTA ADDITION to the City of Klamath Falls, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, more particularly described as follows:
