KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon  
hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto Bruce Hurst  
hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real  
property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath  
Klamath County, State of Oregon, described as follows, to-wit:

Beginning at a point on the E line of Lot 1, Block 16, Klamath Falls Forest Estates, Sycan Unit that is N 900' from the SE corner thereof;  
thence W to the W line thereof; thence Northerly, Easterly and Southerly along the exterior lines of said lot to the point of beginning,  
according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

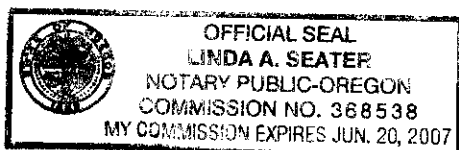
