KNOW ALL BY THESE PRESENTS that Jerry L Pollock

hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto

Jerry Pollockhereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

A portion of the SW 1/4 NE 1/4 of Section 31, Township 37 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon, described as follows:

Beginning at the quarter corner common to Sections 31 and 32, Township 37 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon; thence North 89° 49' West a distance of 1444.55 feet; thence North 1° 10' East 120 feet to the Southeast corner of the Tract herein described; thence North 1° 10' East 200 feet; thence North 89° 49' West 665 feet, more or less, to a point on the Easterly right of way line of the Dalles-California Highway; thence South 19° 35' West along said right of way line 212 feet, more or less, to a point which is North 89° 49' West of the point of beginning; thence South 89° 49' East 735 feet, more or less, to the point of beginning.

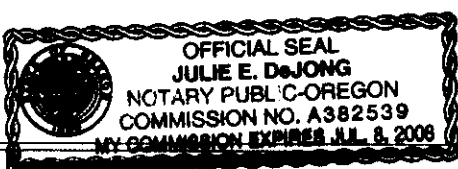
