Lot 4 Block 33, First Addition To Klamath Forest Estates, according to the plat thereof on file in the office of County Clerk of Klamath County, Oregon.

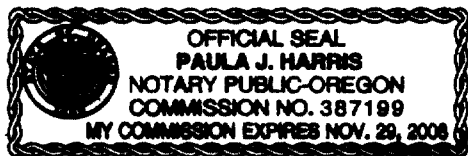
Lot 35 Block 33, First Addition To Klamath Forest Estates, according to the plat thereof on file in the office of County Clerk of Klamath County, Oregon.
