FIRST AMENDMENT TO OPTION AND EASEMENT AGREEMENT

This First Amendment to Option and Easement Agreement (this "Amendment") is entered into between Richard Sacchi, an individual ("Owner") and Peoples Energy Resources Corp., an Illinois corporation ("PERC"), effective as of October 22-2002 (the "Effective Date").

 - The description of the land set forth in Exhibit A to the Option (a) Agreement is hereby amended and restated in its entirety as set forth in Exhibit A to this Agreement.
 - The description of the Easement Area set forth in Exhibit B to the (b) Option Agreement is hereby amended and restated in its entirety as set forth in Exhibit B to this Amendment.
 - The amount of the Final Payment set forth in the Option Agreement is (c)
