
Having received from the Beneficiary under said Trust Deed or Beneficiary's Successor



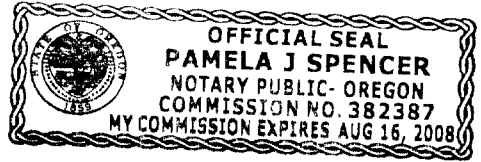
