In Witness Whereof the said vendor has executed this Memorandum June 21, 2005.

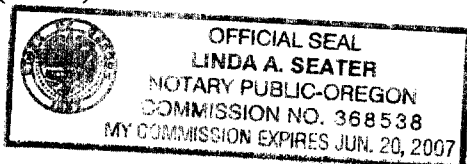
