The true and actual consideration for this transfer is \$3,500,000.00.



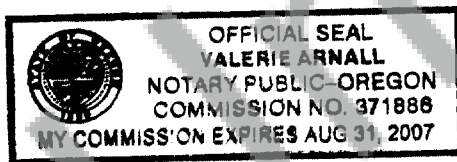
