grantees, their heirs, successors and assigns, a nonexclusive easement described as follows, to-wit:

subject to liens and encumbrances of record, in and upon the following described real property of  
grantors in Klamath County, Oregon to-wit:

The septic lines of various lengths are located approximately 40' from the  
southwest corner (east) of the grantee's property and beginning at approximately 20' from the  
property line. The lines will extend over an area approximately 100 ft in length and 75' wide  
parallel and 50' from the dry wash.  
for the construction, maintenance, use and repair of an individual water-carried on-site sewage  
disposal system (hereinafter called "system" appurtenant to the above described property of  
grantees.

Grantors, for themselves and their heirs, successors and assigns, covenant and agree to  
and with the grantees, their heirs, successors and assigns, that the above-described property of the  
grantors shall not be used for any purpose detrimental to said system or contrary to laws and rules  
of governmental agencies applicable or related to said system.

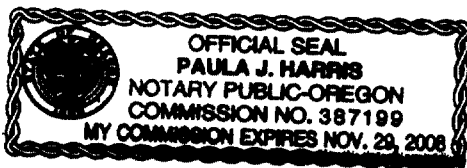

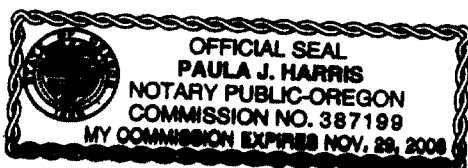
