KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto Dana F. Seymour as to an undivided one-half interest and Stephen R. Camden as to an undivided one-half interest, as Tenants in Common hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

The West 400 feet of Lot 9, Block 18, Klamath Falls Forest Estates, Sycan Unit, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, Excepting therefrom the North 360 feet thereof.

Subject to covenants, conditions, reservations, easements, restrictions, rights, rights of way and all matters appearing of record.

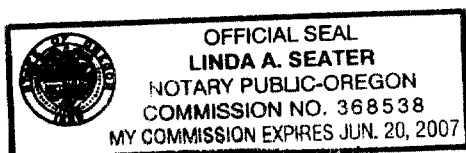
