EXHIBIT "A" LEGAL DESCRIPTION

PARCEL 1:

A parcel of land situated in the SW1/4 of Section 9, Township 39 South, Range 10 East of the Willamette Meridian, Klamath County, Oregon, more particularly described as follows:
