KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto Mike N. Kincade, hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, Sate of Oregon, described as follows, to-wit:

The E $\frac{1}{2}$ W $\frac{1}{2}$ and the E $\frac{1}{2}$ of Government Lot 4, and the NE $\frac{1}{4}$ SW $\frac{1}{4}$ NW $\frac{1}{4}$ and that part of the S $\frac{1}{2}$ SW $\frac{1}{4}$ NW $\frac{1}{4}$ that lays East of the Rimrock of Section 4, Township 36 South, Range 12 East of the Willamette Meridian, Klamath County, Oregon. **Less and excepting therefrom** the N $\frac{1}{2}$ of the N $\frac{1}{2}$ of the E $\frac{1}{2}$ of Government Lot 4 of the NW $\frac{1}{4}$ of Section 4, Township 36 South, Range 12 East of the Willamette Meridian, Klamath County, Oregon.

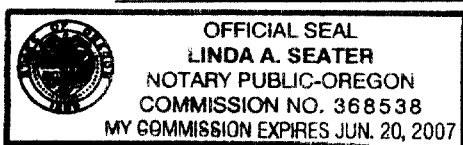
