#### **EXHIBIT A**

### **LEGAL DESCRIPTION:**

The Northerly 40 feet of the Westerly 1/2 of Lot 8, Block 17, Fairview Addition No. 2 to the City of Klamath Falls, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon, more particularly described as follows:

Beginning at the Northwesterly corner of Lot 8 Block 17, Fairview No. 2 Addition to the City of Klamath Falls, Oregon; thence Southerly along the Westerly line of said Lot 8, also being the Easterly boundary of Lakeview Street, a distance of 40 feet; thence Easterly in a straight line and at right angles to the said Easterly boundary of Lakeview Street a distance of 55 feet; thence Northerly and parallel to the said Easterly boundary of Lakeview Street a distance of 40 feet to the Northerly line of said Lot 8; thence Westerly along the Northerly line of said Lot 8 a distance of 55 feet to the point of beginning.
