QUITCLAIM DEED

KNOW ALL BY THESE PRESENTS that Klamath County, a political subdivision of the State of Oregon hereinafter called grantor, for the consideration hereinafter stated, does hereby remise, release and forever quitclaim unto John W. Yoost hereinafter called grantee, and unto grantee's heirs, successors and assigns, all of the grantor's right, title and interest in that certain real property, with the tenements, hereditaments and appurtenances thereunto belonging or in any way appertaining, situated in Klamath County, State of Oregon, described as follows, to-wit:

All of Lot 7 and the South 1½ feet of Lot 4, Block 109 being a strip off the Southeasterly corner of said Lot 4, being 45 feet along the line of Lot 7 of said Block 109 and 1½ feet deep along the alley, all of said lots being located in Block 109, Supplementary Plat of Buena Vista Addition To The City of Klamath Falls Oregon, according to the official plat thereof on file in the office of the County Clerk of Klamath County, Oregon.

Subject to covenants, conditions, reservations, easements, restrictions, rights, rights of way and all matters appearing of record.


