## SPECIAL POWER OF ATTORNEY

To make, indorse, accept, receive, sign, seal, execute, acknowledge, and deliver any documents, instruments, or paper necessary or convenient to purchase in my name and for my use the below-described real property: 10438 Merlin Way, in the Town of Klamath Falls, county of Klamath, state of Oregon and to enter into a mortgage for such price, at such rate of interest and upon such terms as to she shall seem best, but not to exceed \$400,000.00, within these limits: no limitations and further, to record this Power of Attorney in the clerk's office of the county of Klamath, state of Oregon prior to engaging in any of the above-authorized transactions.

FURTHER, this power of attorney shall remain in full force and effect until April 20, 2006, unless sooner revoked by me, provided, however, that such prior revocation shall be of no effect in respect to parties acting or things done in reliance hereon prior to receipt by them of such notice of revocation as may be prescribed by law.



FURTHER, this power of attorney is a durable power of attorney, and it shall not be affected by my becoming disabled, incompetent or incapacitated. Additionally, notwithstanding the preceding paragraph, if I become disabled, incompetent, or incapacitated, this Power of Attorney shall remain in effect until I regain my full mental capabilities. It is my intent that the authority conferred herein shall be exercisable notwithstanding my physical disability or mental incompetence.
