**DEED OF TRUST.** Lender and Grantor have entered into a Deed of Trust dated September 11, 2000 (the "Deed of Trust") which has been recorded in Klamath County, State of Oregon, as follows:

Modified on November 20, 2002, recorded on May 20, 2003 in the office of the Klamath County Clerk of Klamath Falls, Oregon in Volume M03, Page 33973. Modified on May 23, 2003, recorded on May 29, 2003 in the office of the Klamath County Clerk of Klamath Falls, Oregon in Volume M03, Page 36429. Modified on August 4, 2004, in the office of the Klamath County Clerk of Klamath Falls, Oregon, Recorded on August 16, 2004 in Volume M04, Page 53605.

**REAL PROPERTY DESCRIPTION.** The Deed of Trust covers the following described real property located in Klamath County, State of Oregon:

Extending the maturity to June 10, 2006.



Consent by Lender to this Modification does not waive Lender's right to require strict performance of the Deed of Trust as changed above nor obligate Lender to make any future modifications. Nothing in this Modification shall constitute a satisfaction of the promissory note or other credit agreement secured by the Deed of Trust (the "Note"). It is the intention of Lender to retain as liable all parties to the Deed of Trust and all parties, makers and endorser to the Note, including accommodation parties, unless a party is expressly released by Lender in writing. Any maker or endorser, including accommodation makers, shall not be released by virtue of this Modification. If any person who signed the original Deed of Trust does not sign this Modification, then all persons signing below acknowledge that this Modification is given conditionally, based on the representation to Lender that the non-signing person consents to the changes and provisions of this Modification or otherwise will not be released by it. This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.

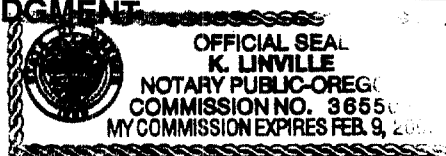
