EXHIBIT "A" DESCRIPTION OF PROPERTY

All of the following described real property situated in Klamath County, Oregon:

Township 38 South, Range 8 East of the Willamette Meridian, Section 36: The SE ¼ NE ¼, and all of the SE ¼, also the SW ¼ NE ¼

Township 38 South, Range 9 East of the Willamette Meridian, Section 31: The SW ¼ NW ¼ and W ½ SW ¼

Township 39 South, Range 9 East of the Willamette Meridian, Section 6: The N ½ N ½

Township 39 South, Range 8 East of the Willamette Meridian,

Section 1: A portion of the N ½ NE ¼ of the Section described as follows:
