

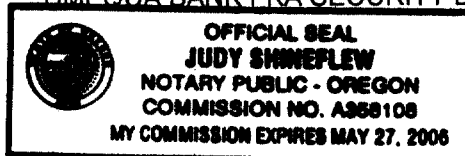

DEED OF FULL RECONVEYANCE



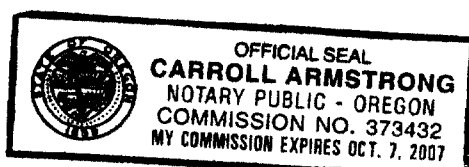
