HILL TRUST DATED JULY 15, 1991, Grantee, an undivided Twenty-Seven and 4403/10000 percent (27.4403%) interest as tenant in common in the parcels of real property described on Exhibit "A" attached hereto, free of encumbrances other than encumbrances of record on the date of this conveyance and those matters which would be shown by an accurate survey or inspection of the premises.

This conveyance is made as a distribution pursuant to the terms of a trust, and the true consideration for this conveyance is \$0.00.

This instrument will not allow use of the property described in this instrument in violation of applicable land use laws and regulations. 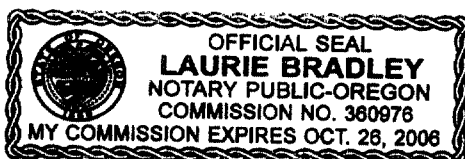
