## **EXHIBIT "A" LEGAL DESCRIPTION**

Beginning at an iron pin which lies North 0° 51' West along the 40 line a distance of 462.3 feet, and North 89° 09' East, a distance of 262.2 feet, and South 46° 09' East, a distance of 428.4 feet from the iron axle which marks the Southwest corner of the NE1/4 of the SW1/4 of Section 1, Township 39 South, Range 9 East of the Willamette Meridian, in the Klamath County of Oregon; and running thence; continuing on South 46° 69' East a distance of 129.4 feet to an iron pin; thence North 43° 51' East, a distance of 384 feet to an iron pin on the Southerly right-of-way line of the Klamath Falls Lakeview Highway, which is 30 feet, measured at right angles from the centerline; thence North 46° 09' West, a distance of 129.4 feet along said right-of-way line to an iron pin; thence South 43° 51' West, a distance of 384 feet to the Point of Beginning.
