RIGHT OF WAY

A strip of land 60.00 feet in width situated in the SE¼ SE¼ of Section 31, Township 37 South, Range 9 East of the Willamette Meridian, Klamath County, Oregon; said strip being 30.00 feet on each side of the following described centerline:
