EXHIBIT A

LEGAL DESCRIPTION:

A parcel of land in the NW1/4 of the SW 1/4 of Section 20, Township 38 South, Range 9 East of the Willamette Meridian, in the County of Klamath, State of Oregon, described as follows:

Beginning 1,320 feet North on the Section line between Sections 19 and 20 from the corner common to Sections 19, 20, 29 and 30 of Township 38 South, Range 9 East of the Willamette Meridian, and 117.11 feet East and at right angles from said Section line common to Sections 19 and 20 of said Township and Range. Then North and parallel to the Section line between said Sections 19 and 20, a distance of 683.9 feet to a point; thence south 62°27' East along highway a distance of 132.09 feet to a point; thence South and parallel to said Section line a distance of 622.8 feet to a point; thence West a distance of 117.11 feet to the place of beginning.

Also beginning at a point 1320 feet north and 234.22 feet East of the corner common to Sections 19, 20, 29 and 30, Township 38 South, Range 9, East of the Willamette Meridian; thence North 682.8 feet; thence South 62°27' East along the Southerly line of highway, 291.88 feet; thence South 553 feet; thence West 258.78 feet to the point of beginning. Save and Except therefrom the following tract: Beginning 2041 feet North and South 63°45' East 264 feet from the Section corner common to Sections 19, 20, 29 and 30, Township 38 South, Range 9 East of the Willamette Meridian; thence South 63°27' East 292 feet; thence North 67 feet, more or less to the Southerly line of the Southern Pacific right of way; thence Northwesterly along said right of way to a point North of the point of beginning; thence South to the point of beginning. Also Saving and Excepting therefrom: That portion deeded to the State of Oregon, by and through its State Highway Commission Recorded September 30, 1955 in Volume 278 page 34, Deed records of Klamath County, oregon.
