The true and actual consideration for this transfer is an estate plan.

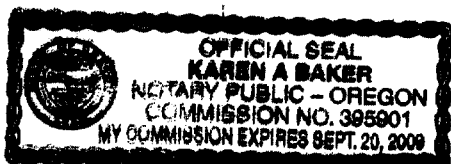
